Application Process for IGEM Postgraduate Masters Scholarships CLOSING DATE FOR APPLICATIONS: 31 May

1. Acknowledgement of Application Form

You will be sent confirmation from the Scholarship Panel upon receipt of your application.

2. What happens next?

Your application and reference forms will be assessed by the Scholarship Panel.

The Scholarship Panel meets in June to select candidates to invite to interview. Candidates who are short-listed will be contacted by email.

Candidates short-listed for interview will be required to supply the following information

A scanned copy of documentation confirming your enrolment on your degree course

A scanned copy of your undergraduate degree results (as soon as available)

As a matter of urgency, please email the Scholarship Panel at **funding@igem.org.uk** and let them know your results as soon as you receive them.

Two references to support your application (to be sent by your referee under seperate cover no later than **31** May).

Candidates who have **not** been short-listed for an interview will be informed by email, after the meeting in June.

PLEASE NOTE THAT THE SCHOLARSHIP PANEL WILL NOT ENTER INTO ANY CORRESPONDENCE REGARDING ITS DECISION.

3. Interviews

Interviews for short-listed candidates have been arranged for July. *We regret that alternative dates cannot be arranged.*

4. What happens at the interview day?

Those short-listed will be invited to attend a virtual interview with the Scholarship Panel. The interview will last approximately 45 minutes and will be based on your application submitted.

If you have any additional requirements to assist you to attend your interview, please notify us in advance so that we can organise the necessary arrangements.

5. After the interview

Following the interview, the Scholarship Panel will notify applicants of the outcome of the interview via email.

NOTE: APPLICANTS MUST BEAR IN MIND THAT THE SCHOLARSHIP PANEL DOES NOT OFFER FEEDBACK FROM THE INTERVIEW AND ITS DECISION IS FINAL.



6. Successful applicants

Successful applicants will be sent an offer by email outlining the amount agreed by the Scholarship Panel.

This will include a reminder of the conditions attached to the scholarship i.e. such as when they will be required to provide their report(s).

Failing to comply with these conditions will mean that IGEM is entitled to ask for a reimbursement of the Scholarship.

Successful applicants are required to notify the IGEM in writing that they still require the scholarship and accept the conditions of supplying a report on the date determined by the Scholarship Panel.

Upon receipt of the confirmation, IGEM will arrange for payment.

7. Reports

Scholarship holders must provide a written report by the date determined by the Scholarship Panel as detailed in the offer letter.

Upon completion of the programme, scholarship holders are required to provide a report to the Scholarship Panel, which is endorsed by the personal tutor or head of department. The report should include a copy of the project thesis or dissertation, which can be a loose-leaf version or digital. The role of IGEM must be acknowledged in any publication arising from any work undertaken for the award of the degree.

Failing to present a report at the agreed time will be considered as a breach of contract and result in the Scholarship Panel seeking to recover any amounts paid.
